ART COMPETITION

Venue: NAST complex, Khumaltar, Lalitpur

Date: Tuesday, 25th April 2017

A. Fine Paper Art Competition

1. Students of class 10 and above are eligible for entry. (Categories-2)
 2. The deadline for registration is: 22 April 2017
 3. The artwork must be a 2-dimensional piece made at the art venue competition itself on the day of the contest. No research material or additional references are allowed. Any paper brought in by the contestants will be confiscated.
 4. Topic will be given on the spot.
 5. The time allocated for the creation of a finished creation is **3 hours**. No additional time will be provided. The contestants must report to the venue by 9am.
 6. The **criteria of judgement** shall be originality, neatness, composition, original composition. (Winner will be decided by: Judging, Polling)
 7. Participants may not put their signatures or any indicators of identity on the front side of the paper but may do so on the back. This is to ensure the artist remains anonymous for each entry during judging to avoid bias.
 8. Use of electronic devices such as mobile phones or any other modes of communication are prohibited during the allocated time until final submission of artwork. All mobile phones and tablets must be switched off and out of sight.
 9. The paper on which the artwork is to be done will be provided by the organisers themselves). Water will also be provided for purposes of painting as well as some scrap paper.
 10. The participants can use any medium of colors. They must bring all requisite material such as pencils, pastels, paints, paintbrushes, palettes, etc.
 11. In case of ambiguity judges are responsible to give final decision.
- Failure to adhere to these rules and regulations can lead to disqualification of the contestant from the event.

B. DNA model Competition

1. Two broad categories are separated for this purpose under 12 class and over 12 class.
2. Any form of DNA model can be presented.
3. Innovation shall be prioritized and further judgement may be done based on the accurate information incorporation.
4. The participants will have to submit and present the DNA model as per the number allocated after submission.
5. The proof of making model must be presented all along a short video and few picture of the procedure are mandatory.
6. Judgement shall be done on basis of Judge and pooling.
7. Final decision is solely dependent on judges.

Cost each group- Rs 400

Not more than 5 members are allowed in a group.

Certificate of appreciation shall be awarded to all the group and individual participating.
Top three will be awarded by the chief guest or higher Delegate.
